




APAH sponsors a concert by jazz singer Karen Akers to raise funds and build awareness for the growing nonprofit.

Groundbreaking takes place for the future Gilliam Place Apartments, the innovative and unique project created in partnership with Arlington Presbyterian Church.

APAH founds the Community

APAH opens Columbia Hills (229 units), its first hybrid 4%/9% Low-Income Housing Tax Credit (LIHTC) project, on excess land at Columbia Grove.



APAH launches its first capital campaign, Uniting to Serve, for its American Legion project. The unique development provides affordable housing with a veterans preference, the first of its kind in Virginia.

APAH approves a new strategic plan encouraging the organization to develop affordable housing beyond Arlington for the first time.

Ron Terwilliger's lead gift of \$1.5 million kickstarts the campaign, and he later names the building after his parents, Lucille and Bruce Terwilliger. The capital campaign raises \$4 million to close the project's financing gap.

APAH opens Gilliam Place (173 units) along with a new church home for Arlington Presbyterian Church.





APAH breaks ground on the redevelopment of Queens Court and acquires Snowden's Ridge (87 units) in Montgomery County – its first acquisition beyond Arlington.


Celebrate Home continues to grow and becomes a go-to affordable housing industry event, raising over \$600,000 for APAH's mission and resident services work.

Lucille and Bruce Terwilliger Place breaks ground in May 2020, during the COVID-19 pandemic. APAH staff continues to meet the needs of residents during the pandemic by providing emergency assistance in the form of food, supplies, health resources, rent relief and eviction moratoriums.

Affordable Housing Finance recognizes APAH for a second time as one of the top 50 largest affordable housing developers in the country.

APAH opens Queens Court Apartments (249 units) and breaks ground on three new communities:

Oakwood Meadow Senior Residences – its first property in Fairfax County, Loudon View Senior Residences – its first property in Loudon County, and Unity Homes at Ballston in Arlington – a partnership with Central United Methodist Church.





APAH's Board adopts its Racial Equity, Diversity, and Inclusion statement and establishes a standing REDI committee.





Nina Janopaul retires after

14 years as CEO, having grown APAH
to a staff of 40 staff, with 2,062 units
at 20 locations, serving over 4,000
individuals and families.

Carmen Romero begins her tenure as CEO.



APAH launches its new mission and vision statements, and adopted a new, 5-year strategic plan to guide the organization's continued growth across the Washington DC Metro region.




APAH opens Oakwood Meadow Senior Residences (150 units) in Fairfax County.

Groundbreaking takes place at the former Marbella Apartments Site A which will bring 234 new units to the Rosslyn community.

The resident services staff count reaches 22, exponentially expanding the reach and impact to residents through the portfolio. The team leverages data analytics to measure thousands of yearly touchpoints, portfolio-wide, and property-specific programmatic efficiency, and continuously learns where there are opportunities for impact.

Resident Services and Asset Management undergo a massive outreach campaign helping residents access over \$7 million in rent relief due to the ongoing effects of the pandemic while maintaining less than a 2% eviction rate.



Celebrate Home moves to Capital One Hall in Tysons, VA, and raises over \$850,000.



Riggs Crossing Senior Residences begins construction in Washington D.C's Ward 4.

APAH acquires Falkland Chase Apartments (north parcel) with 170 units in Silver Spring, Maryland, a property that has plans to dramatically increase in density in the future. APAH was later awarded developer of the year by the Affordable Housing Conference Montgomery County (MD).



Groundbreaking takes place at The Exchange at Spring Hill Station, APAH's largest project ever at 516 units. The building includes a 30,000-square-foot community center operated by Fairfax County. Washington Business Journal later awards the project as its Best Financing Deal of the Year.



The "People's Pantry" opens at the Springs in a former APAH conference room, in response to an increased need for food assistance.



APAH opens Ilda's Overlook Senior Residences (80 units).



### APAH celebrates its 35th anniversary.

Affordable Housing Finance recognizes APAH for the third time as one of the top 50 largest affordable housing developers in the country. This time, APAH is listed as number #19, and is one of only two non-profits in the top 20.

Staff growth reaches 55 people.



APAH opens Unity Homes at Ballston (144 units) in partnership with Central United Methodist Church. The building features a total rebuild of CUMC, as well as a daycare center for 90 children.

APAH owns 23 properties totaling over 2,800 units across the Washington DC Metro region, serving over 5,000 individuals and families, with assets over \$750 million.

Washington Post names APAH a "2024 Top Places to Work", a celebratory nod to the ongoing effort of becoming an 'employer of choice' as noted in the 2023 strategic plan.



APAH board approves renaming the organization to True Ground Housing Partners, aligning with its evolution into a regional developer and service provider.
